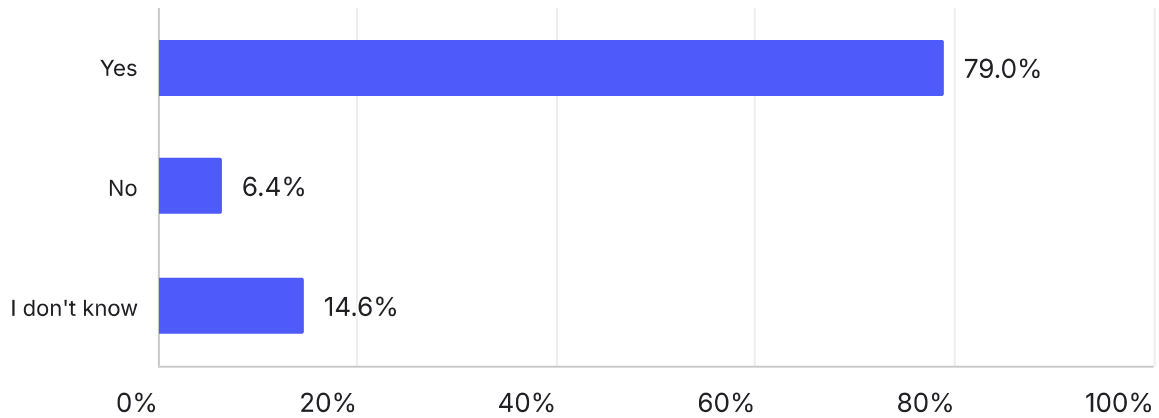

- 1 Do you think wild, public lands (such as BLM or USFS) in the American West should be primarily reserved as habitat for wild, native species?



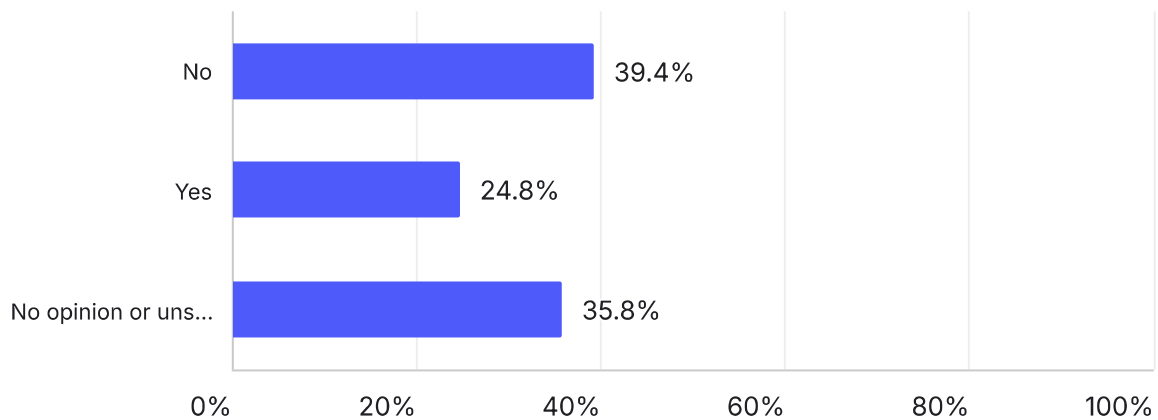

- 2 The modern cow (*bos taurus*) is an invasive, nonnative domestic species originally from Iran and first brought to Europe and later to the American West during the 1800s to replace the native, wild, healthy species of 60 million bison, two million wolves, and many other native species.

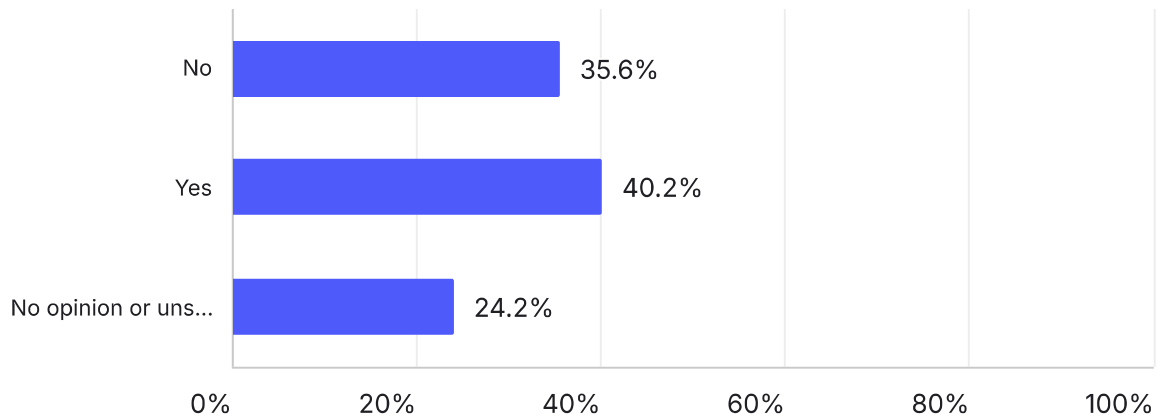

Since 1940, ranchers are allowed to graze their invasive livestock on the majority of public lands in the American West at a mere cost \$1.35 per animal unit (mother cow and calf) per month. This ranching fee of \$1.35 per month has not increased with inflation at all since 1940. If inflation were factored into this fee, ranchers using public lands should now, in today's currency, pay \$31.24 per cow and calf per month. (One dollar fee in 1940 is equal to \$ 23.14 in 2025).

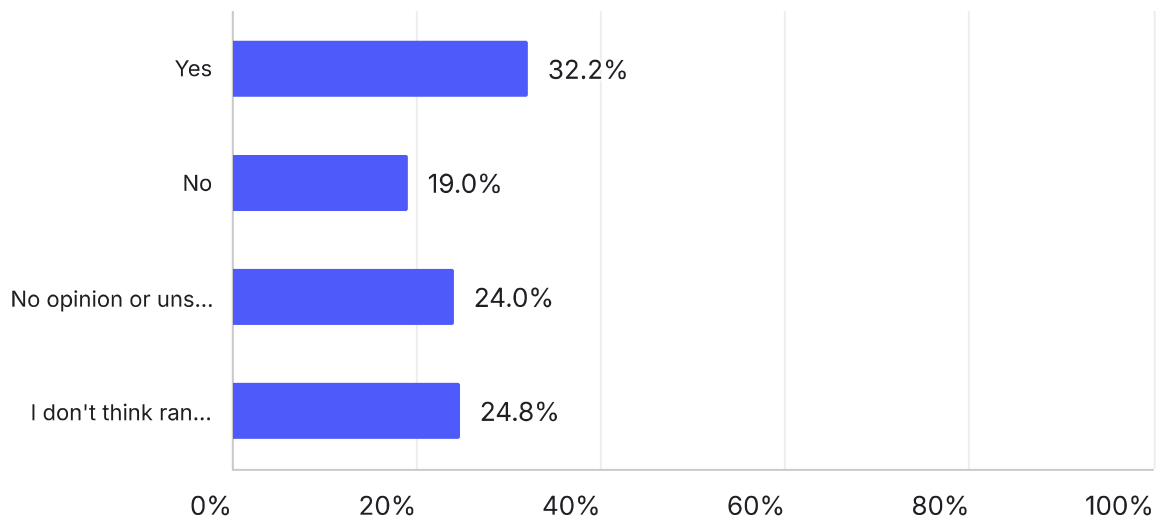

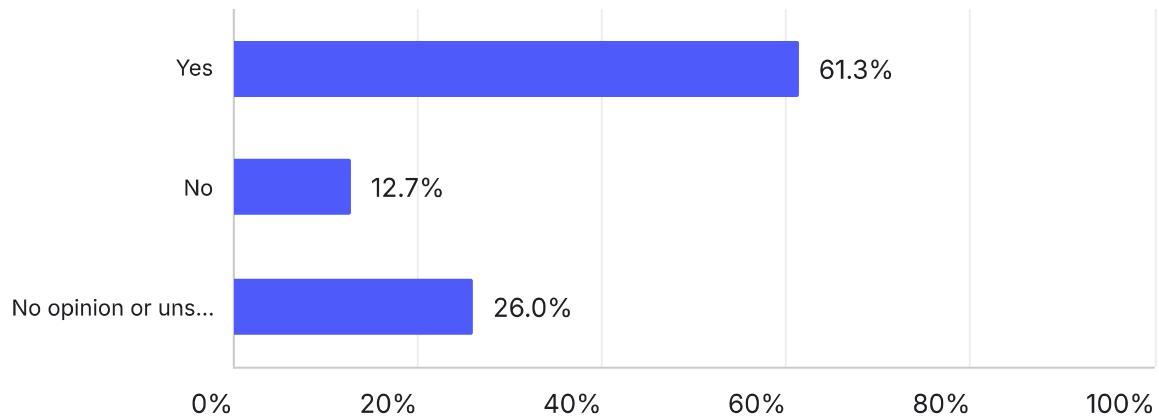

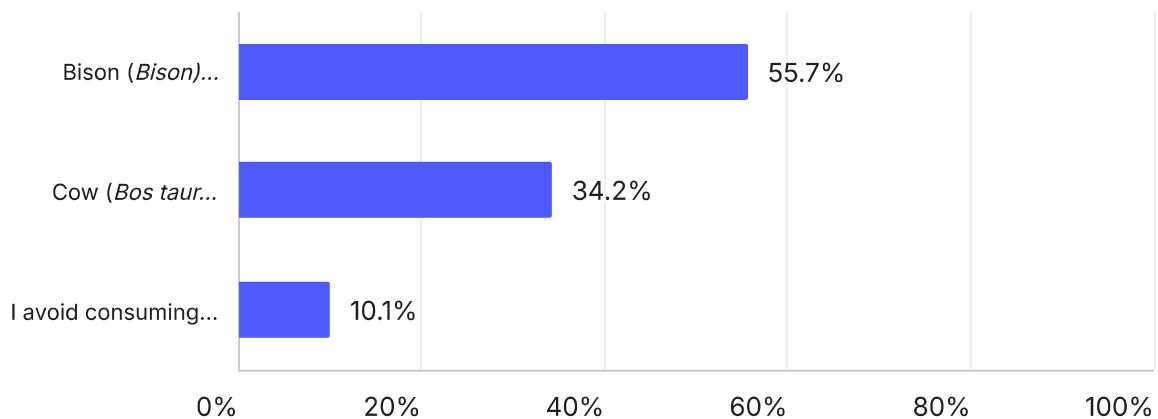

American bison are much healthier for the ecosystem and the human body. Bison meat, unlike gmo-corn fed beef, does not raise oxLDL and does not raise triglycerides. Also, grass-fed, free range bison encourage native seed growth and have up to 10x less methane emissions than a corn-fed cow.

With this health knowledge, if given a choice between a bison or cow steak, which would you choose?

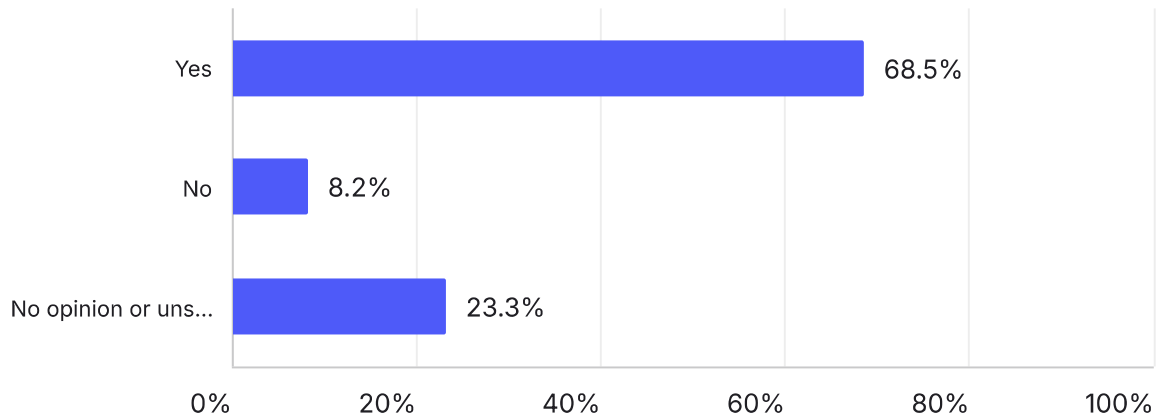

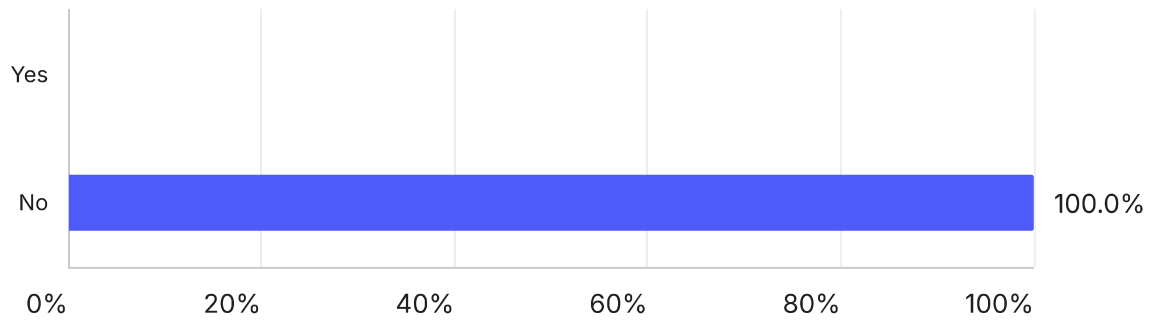

☒ 8 Do you personally work or have family that work in agriculture, ranching, or mining?



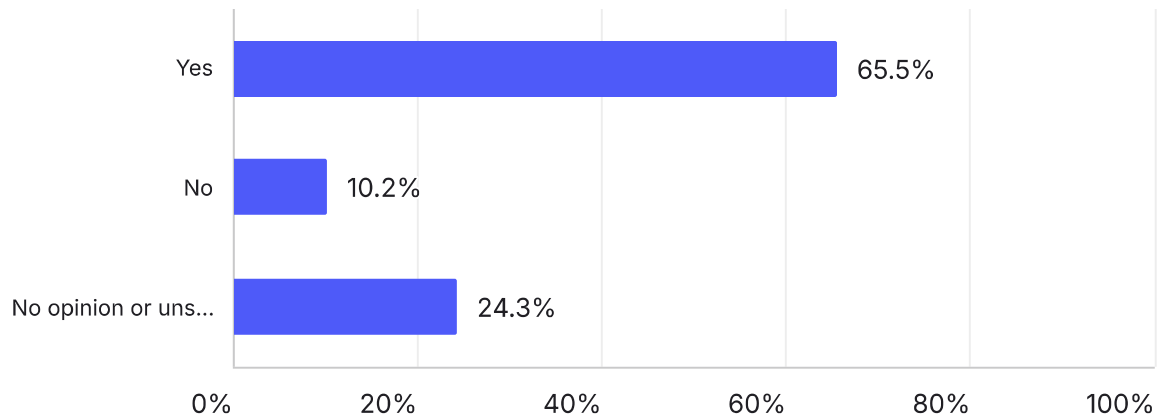

9 Do you consider yourself a good steward of your local and regional ecosystem?

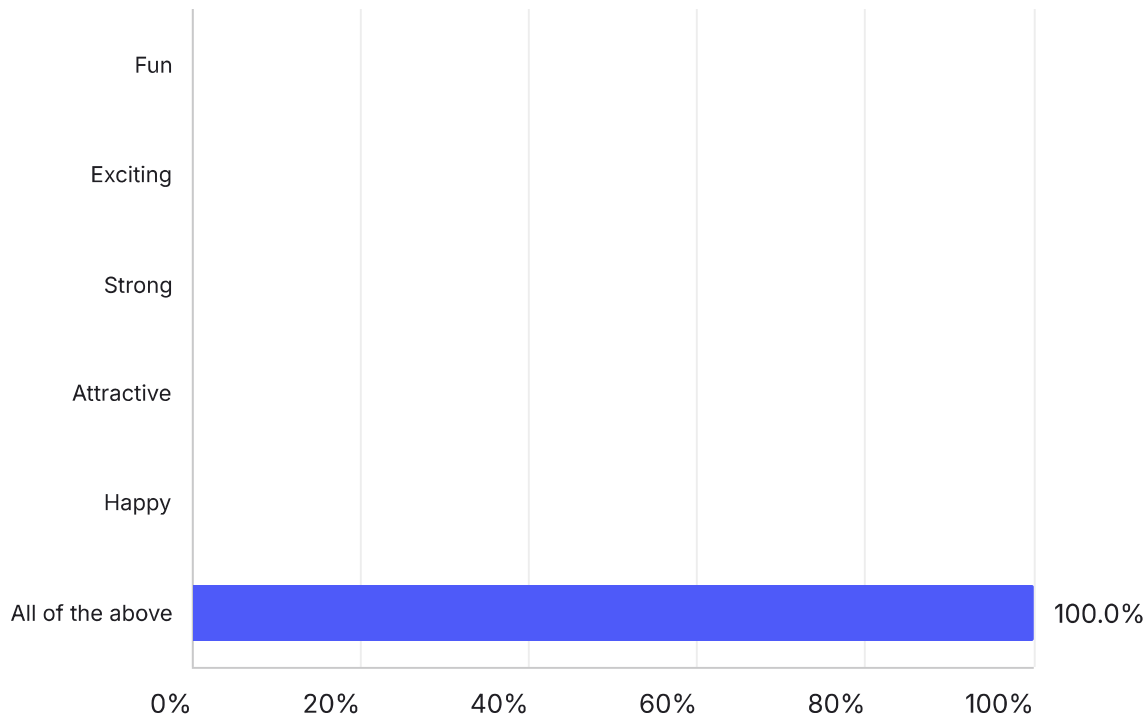
